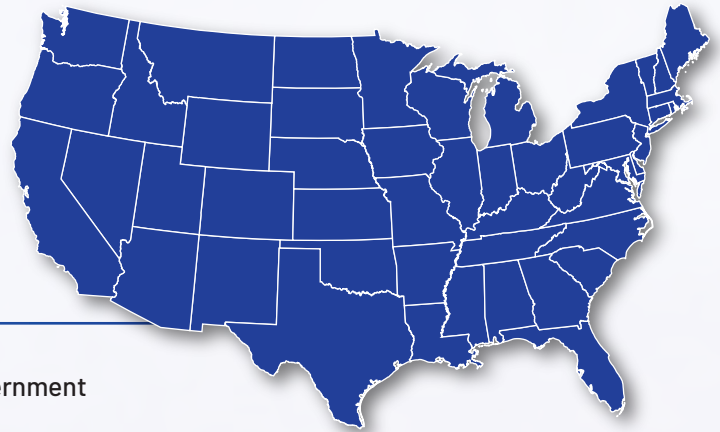

You may link to Customer Service Unit via the website in order to download a petition for authorization and return the petition via fax or mail.

Indexing & Storage: Records available from 1978. New records available for inquiry in 10 days if not submitted electronically.

Searching: Release of criminal records is restricted. All private parties must first write/fax/phone this office and request a "petition package," then apply for a petition number. Employers are eligible to request a petition number; 3rd parties may not, directly. Include in request- set of fingerprints. A signed release is not necessary but is helpful. When applying for fingerprinting, a photo ID is required. 100% of records are fingerprint-supported. All searches require fingerprints and all require an authorization number including government. Investigators and all 3rd parties are considered as agents of employers and must use employer's authorization. All records released to law enforcement; public receives records with conviction data only. Records with dispositions of acquittal are not released to private entities. Per a 2012 U.S. DOJ

Study, 97% of all arrests in database have final dispositions recorded, and 24% of all dispositions received cannot be matched to a specific arrest record.

Access by: mail, in person.

Fee & Payment: The fee is \$18.00 per request, add \$1.00 for a "gold seal." If a statutorily-required FBI fingerprint check is required, fee is \$34.50, or \$33.00 if for child care volunteer. Fee to make fingerprints is \$20.00. Fee payee: CJIS. Prepayment required. Money orders and cashier's checks are preferred. Personal checks accepted. No credit cards accepted.

Mail search: Turnaround time: 10-15 business days. A SASE is not required.

In person search: In person requests are allowed, though signed release and fingerprints are required, and turnaround time is 5 days.

Expedited service: Will rush expedite your request for no add'l charge, however a written request including a legitimate reason why must be submitted. An FBI check cannot be expedited. Will expedite the return if you provide a prepaid shipper envelope.

Indexing & Storage: Records available from 10/01/95. New records available for inquiry in a week if not submitted electronically.

Searching: This data not released: fingerprints, SSN, or the victim's date of birth.

Access by: mail, online.

Mail search: Turnaround time: 1 to 2 weeks. Include requester's full name, address, and reason for the request.

Online search: Online access is free at www.socem.info/. Search by name or ZIP Code. An interactive map is also available.

Other access: A printout is available of partial or complete SOR. Request must be in writing,

Indexing & Storage: Records available on current and former inmates. New records available for inquiry in 1 to 2 days.

Searching: Only location and DOC number are released from this agency. Include in request-inmates race, sex, full name, DOB and the SSN if known. Records computerized since 1980. This data not released: medical and certain personal information

Access by: mail, phone, fax, online.

Fee & Payment: There is no search fee.

Mail search: Turnaround time: 1-3 days. SASE is not requested.

Phone search: Name searching available by phone.

Fax search: Can request via the fax.

Online search: Search inmates online at www.dpscs.state.md.us/onlineserivs/oil/. The search does not include inmates who have been released. The Locator may not list some short sentenced inmates who, although committed to the Commissioner of Correction, are in fact housed at Division of Pretrial and Detention Services facilities.

A search of liens and judgments do not include records from the District Courts nor from the Circuit Court for Prince George's County. The amount of historical information may vary by county based on when an automated case management system was deployed in that county and how the system has evolved. There is a disclaimer.

Indexing & Storage: Records available from 1908 on. New records available for inquiry immediately.

Searching: Officers and directors info is not immediately available. Include in request- full name of business, corporation file number. The following is available; the Articles of Incorporation, Annual Reports, Officers, Directors, DBA's, Prior names (merged names), Inactive and Reserved names.

Access by: mail, phone, fax, in person, online.

Fee & Payment: An abstract of corporate records is \$20.00, a Good Standing is \$20.00. Copies are \$1.00 per page plus \$20.00 to certify. Fee payee: SDAT. Prepayment required. Personal checks accepted. Visa and MasterCard accepted.

Mail search: Turnaround time: 7 days. Officer and director information takes 2 weeks. Expedited service will improve turnaround time for mail or fax requests. SASE not required.

Phone search: Charter information includes date of incorporation, agent, and status. They will let you know how many pages if you wish to order copies.

Fax search: This is considered expedited service, see below.

In person search: The office closes at 4:30 PM for searchers. Public access terminals are available.

Online search: Search for corporate name and trade name records for <http://sdat.resiusa.org/ucc-charter/Pages/CharterSearch/default.aspx>. A Certificate of Good Standing is available online at https://sdatcert1.resiusa.org/certificate_net/ for a \$40.00 fee. Certificates of Status are not available for trade names, name reservations, and sole proprietorships.

Other access: This agency will release information in a bulk output format through a contactor. Obtain prices, formats, production schedules, etc. from Specprint, Inc. Contact Mr. Joe Jenkins of Specprint, Inc. at 410-561-9600.

Expedited service: Expedited service is available for mail and fax searches. Turnaround time- 3 days. There is an additional \$20.00 fee to expedite a copy or expedite a certificate. A credit card must be used if requesting by fax.

Indexing & Storage: Records available for the past 10 years. Trademarks are registered for 10 years before expiring. New records available for inquiry immediately.

Searching: Include in request- trademark/service mark name.

Access by: mail, phone, fax, in person, online.

Fee & Payment: There is no search fee. Certification is \$5.00, copies are \$30 per page. Fee payee: Secretary of State. Prepayment required. Personal checks accepted. No credit cards accepted.

Mail search: Turnaround time: 1 week. No fee for mail request.

Phone search: No fee for telephone request. Only limited information is available.

Fax search: Will return information by mail in 1 week.

In person search: No fee for request. Call before visiting.

Online search: Online searching is available at www.sos.state.md.us/Registrations/Trademarks/TMSearch.aspx. Search can be by keyword in the description field, the service or product, the owner, the classification, or the mark name or keyword in the mark name. The site also offers application forms to register, renew, or assign trade and

service marks, and general info about registration. The Secretary of State also offers a search of Charities at www.sos.state.md.us/Charity/SearchCharity.aspx.

Other access: A computer printout of all marks registered, renewed or assigned within a 3 month period is available for \$.05 per trademark.

This agency will not perform a general name or entity search for the public. A searcher go to the Clerk's office in person, hire a retriever, use the Internet, or buy the database.

Indexing & Storage: Records available for all active files.

Searching: Tax liens are not filed here, but are filed with the clerk of the circuit court of the debtor's jurisdiction. For help, email charterhelp@dat.state.md.us.

Access by: mail, in person, online.

Fee & Payment: There is no search fee. The copy fee is \$1.00 per page. Certification is \$20.00. Fee payee: Department of Assessments & Taxation. Prepayment required. Personal checks accepted. No credit cards accepted.

Mail search: Will not do name searching, but will make copies if exact number of pages paid in advance.

In person search: Records can be viewed at no charge on public access terminals.

Online search: The home page or <http://sdatcert3.resiusa.org/ucc-charter/Pages/UCCSearch/default.aspx> offers free access to UCC index information. Also, there is a related site offering access to real property data by county at <http://sdat.resiusa.org/RealProperty/Pages/default.aspx>. The terms of use for the SDAT web site prohibit any form of automatic or robotic data collection, extraction or copying, such as data mining or web scraping.

Other access: The agency has available for sale copies of public release master data files including corporation, real estate, and UCC. In addition, they can produce customized files on paper or disk. Visit the website for more information.

Records not maintained by a state level agency.

All tax liens are filed at the county level.

Indexing & Storage: Records available on a computer index for the past 4 years of applicants. New records available for inquiry in 7 days.

Searching: This agency will only confirm that a business's number is valid and confirm the name and address of the business. They will provide no

other information. The business name and federal ID# or SSN of owner is required to search.

Access by: mail, phone, fax, online.

Fee & Payment: There is no search fee.

Mail search: Turnaround time: 7 working days. Records are not returned by mail, they will call you. SASE not required.

Phone search: Call only if you have the permit number.

Fax search: Records are available by fax.

Online search: Using the web, one can determine if a MD sales tax account number is valid. See <https://interactive.marylandtaxes.com/Business/VerifyExempt/User/Home.aspx>.

Birth certificates for individuals born in Maryland after 1939 are also available for same day service at local health departments in all jurisdictions except Montgomery County, Baltimore City, and Baltimore County.

Indexing & Storage: Records available from 1898 to present for all counties and 1910 to present for City of Baltimore. For prior records, contact the State Archives. New records available for inquiry in 4 to 6 weeks.

Searching: Must have a notarized signed release from person of record or mother or father, unless requester is parent or guardian or person listed. Include in request- full name, names of parents, mother's maiden name, date of birth, place of birth, relationship to person of record. Requester must supply valid photo ID. A request form is at http://dhmh.maryland.gov/vsa/Documents/apps/ab_capp.pdf.

Access by: mail, phone, fax, in person, online.

Fee & Payment: The search fee is \$12.00. The commemorative birth certificate fee is \$50.00. Fee payee: Division of Vital Records. Prepayment required. Cash is accepted for walk in requesters only. Personal checks accepted. Major credit cards accepted as indicated.

Mail search: Turnaround time: 2 to 3 weeks. A SASE is requested. Be sure to submit photocopies of required identification.

Phone search: See expedited service. Turnaround time is 3-5 days.

Fax search: See expedited service.

In person search: Turnaround time is same day (typically, 15 to 30 minutes). Walk in requesters may pay with cash or check; no credit cards. Presentation of original photo ID is required for walk in requesters.

Online search: Records may be ordered from a designated vendor at www.vitalchek.com. Use of credit card is required and additional \$7.00 fee required.

Expedited service: Expedited service is available for online and fax searches from VitalChek.com. Turnaround time- 2 days. There are additional fees for using this service plus for the use of a credit card. Add express ship fees, if desired.

Local health departments issue certified copies of death records, but they may charge an additional administrative fee to cover costs associated with processing and issuing vital record requests.

Indexing & Storage: Records available from 1969 to present. For records prior to 1969 contact Maryland State Archives, 410-260-6429. New records available for inquiry in 2-3 weeks (if filed at county).

Searching: Must have a signed release from immediate family member. A signature is required from the requester. Include in request- full name, date of death, place of death, relationship to person of record, reason for information request. Request must be signed. Include copy of photo ID with request. A request form is at http://dhmh.maryland.gov/vsa/Documents/apps/ab_capp.pdf.

Access by: mail, phone, fax, in person, online.

Fee & Payment: The fee to search and obtain a record is \$24.00. Each additional copy is \$12.00. Fee payee: Division of Vital Records. Prepayment required. Personal checks, money orders accepted. Major credit cards accepted as indicated.

Mail search: Turnaround time: 2 to 4 weeks. A SASE is requested.

Phone search: See expedited service. Turnaround time is 2-3 days.

Fax search: See expedited service.

In person search: Turnaround time is same day.

Indexing & Storage: Records available from 1990 to present. Prior records must be obtained from the court of record or Archives. New records available for inquiry in 6 months.

Searching: Must have a notarized signed release from persons of record or authorized representative. Include in request- names of husband and wife, date of marriage, place or county of marriage, besides permission letter. Include copy of photo ID with request. At least one of the photo ID documents must contain the requester's current mailing address. A request form is at http://dhmh.maryland.gov/vsa/Documents/apps/am_capp.pdf.

Access by: mail, phone, fax, in person, online.

Fee & Payment: The search fee is \$12.00. Fee payee: Division of Vital Records. Prepayment required. Personal checks, money orders accepted. Major credit cards accepted as indicated.

Mail search: Turnaround time: 2 to 3 weeks. A SASE is requested.

Searching Standards for Federal Courts:

District Courts index by defendant, plaintiff, and by case number. Bankruptcy Courts usually index by debtor and case number. Most case files created prior to 1999 were maintained in paper format only. Since 2006, all cases are filed electronically. Paper case files may be stored at the courthouse or forwarded to a designated Federal Records Center (see <http://archives.gov/frc>), the timeframe determined by the Court. These case files may be obtained via the Court or directly from the FRC.

Case data may be viewed PACER, the online public access program. An account is required, the fee is \$.10 per page; there is no fee if a usage does not exceed \$15.00 in a quarter. For details about PACER see the Appendix or go to <https://www.pacer.gov> or call 800-676-6856.

The copy fee is \$.50; \$.10 if electronic document is printed from terminal. Certification fee is \$11.00 per document and \$21.00 for exemplification, if available. If a case is still available from the individual federal court, the search fee is \$30.00. If the case is at the Archives, the case can be ordered from the court. The fee to retrieve a paper file is \$64.00 for the first box and \$39.00 ea add'l box. Also, the public can order copies direct online from the National Archives. The Maryland Court of Appeals is the highest court in the state (commonly called the Supreme Court in other states). The Court of Special Appeals is Maryland's intermediate appellate court, and it generally considers any reviewable judgment, decree, order, or other action of the circuit and orphans' courts. Details on the Court Structure

Circuit Courts generally handle the State's major civil cases and more serious criminal matters, along with juvenile cases, family matters such as divorce, and most appeals from the District Court, orphans' courts and administrative agencies. The Circuit Courts also can hear cases from the District Court (civil or criminal) in which one of the parties has requested a jury trial, under certain circumstances.

The District Court hears both civil and criminal cases involving claims up to \$30,000, and has exclusive jurisdiction over peace order cases and landlord/tenant, replevin (recovery of goods claimed to be wrongfully taken or detained), other civil cases involving amounts at or less than \$5,000, certain juvenile case, and traffic cases. The District Court also handles motor vehicle/boating violations and other misdemeanors and limited felonies, although the circuit courts share jurisdiction if the penalties authorized are three years or more in prison, a fine of \$2,500 or more, or both. Both trial courts can hear domestic violence cases. A case in the District Court is argued before a judge only: there are no jury trials in District Court.

Orphans' Courts handle wills, estates, and other probate matters. In addition, they have jurisdiction—along with the circuit courts—to appoint guardians of the person, and to protect the estates of un-emancipated minors (minors who remain under parental authority).

The Circuit Court handles probate in only Montgomery and Harford counties. In other counties, probate is handled by the Orphan's Court. The clerk is called the Register of Wills and is a county, not a court, function.

Note there are both a Baltimore County and the City of Baltimore; each has its own courts.

Record Searching Facts You Need to Know

Fees and Record Searching Tips

A fee schedule dictates that courts must charge \$5.00 for document certification in all courts. Most courts charge \$.50 per page for a copy. Most courts will not do a name search for the public, those that do rarely charge a search fee.

Online Access is Statewide

See <http://casesearch.courts.state.md.us/inquiry/inquiry-index.jsp> for a free search of dockets of the trial courts, including civil, traffic and criminal. A search of civil or criminal includes all District and Circuit courts in the state - but a search of liens and judgments does not include the District Courts and the Circuit Court for Prince George's County.

Note the DOB is shown on some but not all dockets. Records are updated daily, but case information from Montgomery and Prince George's counties usually lag one additional day. All case information may be searched by party name or case number. The amount of historical information may vary by county based on when an automated case management system was deployed in that county and how the system has evolved. Note the disclaimer: *This site reflects the electronic record of the cases presented and may not always reflect the information*

maintained within the official case file. The data may not be reliable in the sense that further action may occur in the case that would affect the record.

Bulk subscription data of civil record information from the District Courts can be requested for an annual and monthly fee - see www.courts.state.md.us/district/forms/acct/dca107.pdf. Reportedly, plans are underway for subscribing parties to access statewide Case Search bulk data and data extracts through a standards-based interface in XML format. Also, there is an Attorney Calendar Service that displays information related to an attorney's trial and hearing schedule such as case number, attorney name, trial or hearing date, defendant name, time, room, etc.

- Tax Lien and UCC Record Searching:** As mentioned above, all tax liens are filed with the county Clerk of Circuit Court. Counties will not perform name searches. You must hire a retriever to search.
- Since July 1995 all new UCC filings except for consumer goods, farm-related and real estate-related filings are submitted only to the central filing office. Starting July, 2001, only real estate related filing are submitted to the Clerk of Circuit Court.

The Maryland Judiciary, the 24 elected Maryland Court Clerks, and Maryland State Archives all joined in partnership to provide an up-to-date access to all verified land record instruments in Maryland. This service is currently being provided free to individuals who apply for a user name and password. See <http://www.mdlandrec.net/main/>

Property Tax Records

You will usually be able to find the city name in the City/County Cross Reference below. In that case, it is a simple matter to determine the county from the cross reference. However, only the official US Postal Service city names are included in this index. There are an additional 40,000 place names that people use in their addresses. Therefore, we have also included a ZIP/City Cross Reference immediately following the City/County Cross Reference.

If you know the ZIP Code but the city name does not appear in the City/County Cross Reference index, look up the ZIP Code in the ZIP/City Cross Reference, find the city name, then look up the city name in the City/County Cross Reference. For example, you want to know the county for an address of Menands, NY 12204. There is no "Menands" in the City/County Cross Reference. The ZIP/City Cross Reference shows that ZIP Codes 12201-12288 are for the city of Albany. Looking back in the City/County Cross Reference, Albany is in Albany County.
