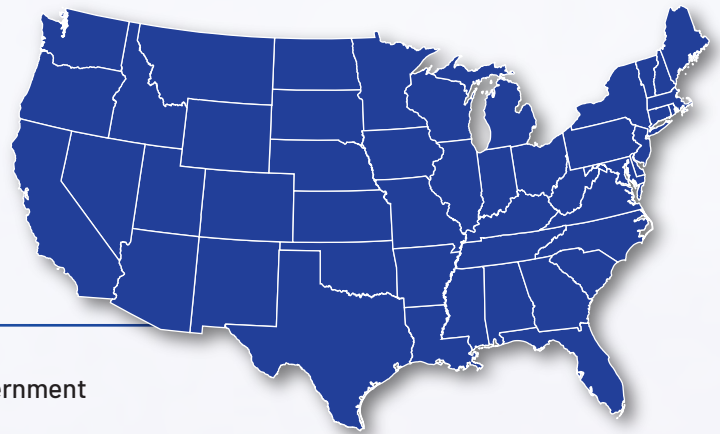

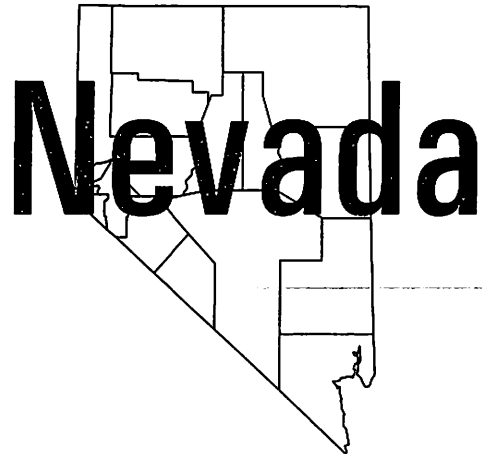

State Agencies

Criminal Records

Records are available if you provide fingerprints and consent of subject. Otherwise, this agency suggests a court record search instead.

Indexing & Storage: Records available from 1987 and are on computer. Records are maintained indefinitely, unless sealed due to court order or on the death or 100th birthday of the individual. New records available for inquiry in 2-3 weeks.

Searching: This repository maintains all retainable criminal charges as defined by state statute including DUI and domestic violence. 100% of arrest records are fingerprint supported. Include in request- set of fingerprints, signed release, full name, DOB, SSN, sex and race. Form DPS-006 is suggested. See www.nvrepository.state.nv.us/Criminal/forms/DPS_006_Form.pdf. Fingerprinting services may be obtained at a law enforcement agency, any authorized private business or at the Records Bureau. The ID form DPS-006, can be obtained by mail, fax or in person from the Records Bureau. This data not released: sealed records or juvenile records. Records without dispositions are released. Per a 2012 U.S. DOJ Study, 45% of all arrests in

database have final dispositions recorded, and 23% of all dispositions received cannot be matched to a specific arrest record.

Access by: mail, in person, .

Fee & Payment: The fingerprint search fee is \$21.00 per individual. If the search requires an FBI fingerprint check (for record checks on occupations concerning children or the elderly, per state statute add \$27.50 for manual, or \$16.50 for live scan. Fee payee: Nevada Department of Public Safety Prepayment required. Money order or cashier's check required. Misdemeanor traffic records and juvenile records are not released. Personal checks not accepted. Credit cards and cash not accepted.

Mail search: Turnaround time: 30 days. SASE not required.

In person search: Records are still returned by mail.

Sexual Offender Registry

In 1997, the Community Notification of Sex Offenders law was passed (NRS Chapter 179D). There are over 16,725 offenders (active and inactive) registered in the state.

Indexing & Storage: Records available from 1997 forward on computer and a hard copy file. New records available for inquiry in 60-90 days.

Searching: Email questions to sorhelp@dps.state.nv.us. Include in request- name, offense, DOB, DL or SSN. The agency will NOT respond to name search requests by mail, phone or fax.

Access by: mail, phone, online.

Fee & Payment: There is no search fee.

Mail search: Mail requests are not honored.

Phone search: Call the 775-684-6262 number.

Online search: Note: Per state law (NRS 179B.270), a search of this free public database online CANNOT be used for employment purposes. Information available on the website is extensive, including aliases, photograph (where available), conviction information, and latest registered address. Search by name, ZIP Code, or license plate number. There is no fee. Data is provided for sex offenders with a risk assessment score of a TIER Level 3 or TIER Level 2.

Indexing & Storage: Records available on current inmates. Former inmates records are archived and will take longer to obtain. New records available for inquiry in 1 to 3 days.

Searching: For a copy of a file record, one must have a court order or subpoena. Records are archived after one year. Include in request- full name; DOC number helpful. Location, conviction and sentencing information, case number, and release dates are released. Searches can be done back to 1864, with varying results. This data not released: medical and mental health data, disciplinarians, correspondence, chronos. For medical, mental, psych records, must r

Access by: mail, fax, online.

Fee & Payment: There is a \$.25 fee per page. Fee payee: Department of Corrections. Prepayment required. Personal checks accepted.

Mail search: Turnaround time: 30 days. SASE not required.

Fax search: Only if for medical, mental, psych records. Must fax request to Denise Breeden, medical records, to 775-887-9288.

Online search: Search inmates at www.doc.nv.gov/inmatesearch/form.php.

Statewide Court Records

Except for certain online research capabilities, all court record access must be done at the local level. The state does not have a unified court system database. Email questions to aocmail@nvcourts.nv.gov.

Online search: Many searches are offered at www.nevadajudiciary.us/index.php/supremecourt. Includes Supreme court and Appellate cases, opinions and decision. Note some Nevada Courts have internal online computer systems, but only Clark and Washoe counties offer online access of a record index to the public. A statewide court automation system is being implemented.

Indexing & Storage: Records available since inception of laws (1912). Old, inactive records are purged from computer and archived. Most can still be accessed manually by request. New records available for inquiry in current (but 7-10 days if filed manually).

Searching: Search requests must be on letterhead or use this agency's form, which is preferred. Download forms at www.nvsos.gov/index.aspx?page=51. Agency suggest to search online first. Include in request-full name of business, corporation file number. Credit card payment info can be included on request form. In addition to the articles of organization, business entity records available include: Annual Lists of Officers & Directors,

Prior (merged) names, Inactive and Reserved names, and Resident Agent names. This data not released: payment and fee data, correspondences.

Access by: mail, phone, fax, in person, online.

Fee & Payment: The search fee is \$50.00. The certification fee is \$30.00. Copy fees are \$2.00 per page. A Certificate of Good Standing is \$50.00. Fee payee: Secretary of State. Prepayment required. Trust accounts can be established especially for phone requesters. Personal checks accepted. Major credit cards accepted.

Mail search: Turnaround time: 1 to 2 weeks. SASE not required.

Phone search: Staff will give status for corporations and partnerships, corporate officer names, and trademark information.

Fax search: One may request searches and copies by fax. Fax to use for status request is 775-684-5645

In person search: Public Access Terminal is the same as the web. Information requests are available.

Online search: Search online at <http://nvsos.gov/sosentitysearch/CorpSearch.aspx>. Also includes Trademarks, Trade Names, Service Marks, Reserved Names & Business Licenses. Search by corporate name, resident agent, corporate officers, or by file number. To broaden the search, enter only the main name without entity suffixes (Inc, LLC, LP etc.) Also, good standing certificates can be ordered online - no add'l search fee. Email search requests are encouraged, copies@sos.nv.gov. Note that most orders may be emailed back if email is provided. There is also a search offered at the state's Business Portal at www.nvsilverflume.gov/home.

Other access: Reports and data downloads available - Foreign Corporation lists, Non-Profits, for example - under the Online Services tab at the website; fees vary.

Expedited service: Expedited service allows copies to be picked up in person or sent by mail, but fax back service is available on 1-hour and 2-hour expedite orders for certificates or copies of 50 pages or less. Turnaround time- 1, 2 or 24 hours. The expedite search fee for 24 hours is \$125.00. 2 hour service is \$500. 1 hour service is \$1,000.

Assumed Name, Fictitious Name

Records not maintained by a state level agency.

DBA's are filed at the county level, not with the Secretary of State. Contact the clerk or recorder's office in the county where the document was filed.

Trademarks/ServiceMarks

Trademark files are kept here and copies of document must be requested from this office. The SOS office in Carson City can look records on computer, but cannot make copies of actual documents in files.

Indexing & Storage: Records available since inception.

Searching: The same search requirements apply here as in Carson City.

Access by: mail, phone, in person, online.

Fee & Payment: The search fee is \$50.00. Copies are \$2.00 per page and \$30.00 for certification per document. Fee payee: NV Secretary of State. Prepayment required. Personal checks accepted. Major credit cards accepted.

Mail search: Turnaround time: 1 to 2 weeks.

Phone search: Limited information is offered over the phone.

In person search: Turnaround immediate, time permitting.

Online search: Search marks at <http://nvsos.gov/sosentitysearch/>. While this may look like a business entity search, it will bring up marks. Look on the document number; SM is servicemark; TM is trademark.

Expedited service: Turnaround time- 1-2 or 24 hours. 24-hour expedite fee for 1 to 10 pages \$75.00; 11 or more pages \$125. The 2-hour expedite fee is \$500.00. The 1-hour expedite fee is \$1000.

Uniform Commercial Code, Federal & State Tax Liens

Federal tax lien search must be requested separately and only contains data on businesses. Tax liens on individuals are filed at the county level. There is no state income tax, thus no recorded state tax liens.

Indexing & Storage: Records available from 1967 on both computer and microfilm. New records available for inquiry in 1-2 days.

Searching: Use search request form UCC-11. The agency will email documents to requester, if asked. Include in request- debtor name. For filers, note that effective Friday, March 12, 2010, fees for certain UCC and Dissolution filings increased.

Access by: mail, fax, in person, online.

Fee & Payment: The fee for online file is \$30; a written filing is \$60.00. Copies cost \$2.00 per page. Remember a tax lien search is a separate fee. Fee payee: Secretary of State. Prepayment required. Personal checks accepted. Major credit cards accepted.

Mail search: Turnaround time: 1 to 3 days. A SASE is requested.

Fax search: See expedited service.

In person search: Counter service available for drop offs is available.

Online search: Searching is available at <https://nvsos.gov/NVUCC/user/login.asp>, note registration is required. To receive documents the fee is \$30.00, an order form may be downloaded. A full commercial system is also available.

Other access: Bulk purchase services are available to those with an account. See <https://nvsos.gov/NVUCC/user/login.asp> and sign in. Must have an account with email and password.

Expedited service: Expedited service is available for mail and fax request searches. Searches will not be returned by fax. Turnaround time- 2 or 24 hours. For 24 hour service, add \$125.00. For 2

hour service, add \$500 if for 1 to 10 copies, \$1000 if 11 or more copies. One hour service is \$1,000.

Sales Tax Registrations

Records not maintained by a state level agency.

State does not impose sales tax.

Indexing & Storage: Records available from 1911 to present. New records available for inquiry in 30 days of filing.

Searching: Birth and death records are considered confidential and not open to the general public. Include in request- full name, names of parents, mother's maiden name, date of birth, place of birth, relationship to person of record, reason for information request. Parents' names are a must to get record.

Access by: mail, phone, fax, in person, online.

Fee & Payment: For a certified copy the fee is \$20.00. Fee for request for search records is \$10.00. The form for this search is found at www.health.nv.gov/VS/SearchRequest.pdf. If you wish to purchase using a credit card, see expedited service. Fee payee: Office of Vital Statistics. Prepayment required. Personal checks accepted. Major credit cards accepted by vendor.

Mail search: Turnaround time: 10 to 15 days. SASE not required.

Phone search: See expedited service.

Fax search: See expedited service.

In person search: Turnaround time 20 minutes.

Online search: Online ordering available from state designated vendor at www.vitalchek.com.

Expedited service: Expedited service is available for online, phone and fax requests from VitalChek. Add vendor fee of \$10.95 plus express delivery fee is desired. A credit card is required.

Indexing & Storage: Records available from 1911 on. New records available for inquiry in 30 days of filing.

Searching: Records are considered confidential, need to state relationship. However, a verification printout with name, date, and location is available to the public. Include in request- full name, date of death, place of death, relationship to person of record, reason for information request.

Access by: mail, phone, fax, in person, online.

Fee & Payment: The fee for a verification only or if no record found is \$10.00. A certified copy is \$20.00. Fee payee: Office of Vital Statistics.

Prepayment required. Personal checks accepted. Major credit cards accepted by vendor.

Mail search: Turnaround time: 10-12 working days. SASE not required.

Phone search: See expedited service.

Fax search: See expedited service.

In person search: Turnaround time is 20 minutes.

Online search: Expedited service is available from state designated vendor at www.vitalchek.com.

Expedited service: Expedited service is available for online, phone and fax requests from VitalChek. Add vendor fee of \$10.95 plus express delivery fee is desired. A credit card is required.

Marriage Certificates, Divorce Records

Access to Records is Restricted.

Marriage records are at the county recorder office of issue, divorce records with the county clerk of issuance. This office will verify a post 1968 record exists for \$10.00, and will sell microfiche index of marriage (\$200) or divorce (\$100). This agency will sometimes be able to verify if a record exists with an index search.

Since 1/1/00, Nevada privatized the business of workers' compensation insurance. This agency holds an index of statewide records, but data cannot be disclosed unless the requester is listed in NRS 616B.012. Direct questions to WCSHelp@business.nv.gov.

Searching: Bottom line is the index is not available to employers for post-hire research, even with a signed release. However on can confirm if an employer has coverage - see online below.

Online search: For the Employers' Workers' Compensation coverage verification link go to <http://dirweb.state.nv.us/WCS/cvs.htm>. Coverage Verification Service (CVS) users can verify workers' compensation coverage of employers who have policies with private carriers. A search resulting in NO RECORDS FOUND on CVS does not necessarily indicate that coverage does not exist.

Copies of citations may be obtained at the same address. There is no fee when requesting your own citation, otherwise the fee is \$8.00.

Indexing & Storage: Records available for 3 yrs to 10 yrs depending on the type of record ordered.

Non-moving violations not listed on the driving record for non-CDL drivers.

Searching: Authorized users may establish an account by completing the appropriate application. Call 775-684-4590 to request an application. Casual requesters without written consent of subject receive records without personal information. The driver's license number, or name and DOB are needed for a request. The SSN is helpful for searching, but is only released on the record to government agencies. Accidents do not appear on the record.

Access by: mail, phone, fax, in person, online.

Fee & Payment: The fee is \$7.00 per driving record or \$5.00 for license information. Add \$4.00 for certification. Three record types are available (except online): three-year, ten-year, and school bus records. Fee payee: Nevada Department of Motor Vehicles. Prepayment required. Personal checks accepted. Credit cards accepted.

Mail search: Turnaround time: 10 days. Request must be on department approved forms. SASE not required.

Phone search: Phone-in requesters must be pre-approved, are assigned a 5-digit account number and can request up to 5 records at one time over the phone. Call 775-684-4590 for information.

Fax search: Pre-approved accounts may fax requests.

In person search: Drivers may obtain their own record from any DMV office, but the address above is the only location that provides certified records.

Online search: The state has an FTP system available for high volume users. All files received by 5:30 PM are processed and returned at 6:30 PM. Fee is \$7.00 per record. Call 775-684-4702 for details. Also, a batch processing system has recently been added for higher volume accounts. Only three-year histories are available electronically. Details on the Court Structure

The **District Court Clerk** maintains the official court record for felony or gross misdemeanor criminal, divorce, juvenile, probate, adoption, paternity, child support, and civil court cases in excess of \$10,500. Probate is handled by the District Courts, as are divorce records. The judges also hear appeals from Justice and Municipal Court cases.

The **Justice Courts** are generally named for the township of jurisdiction. Due to their small populations, some townships no longer have Justice Courts. The Justice Courts handle misdemeanor crime and traffic matters, small claims disputes, evictions, and other civil matters less than \$10,000, the maximum amount for Small Claims increased from \$5,000 to \$7,500 in July 2011. The Justices of the Peace also preside over felony and gross misdemeanor arraignments and conduct preliminary hearings to determine if sufficient evidence exists to hold criminals for trial at District Court.

The **Municipal Courts** manage cases involving violations of traffic and misdemeanor ordinances that occur within the city limits of incorporated municipalities. Generally they do not oversee civil matters.

Record Searching Facts You Need to Know

Fees and Record Searching Tips

The search fee and the copy fee for records at the District Court (and not Justice Court) are set by statute at \$.50 per record. This fee was effective October 1, 2013. The previous fee was \$1.00 per record or copy.

Many Nevada Justice Courts are small and hold few records. Their hours of operation vary widely and contact is difficult. It is recommended that requesters call ahead for information prior to submitting a written request or attempting an in person retrieval. Fees will vary, but approx. 70% of the Justice Courts charge \$1.00 per name per year to do a name search.

Online Access is Limited

Some Nevada courts have internal online computer systems, but only Clark and Washoe counties offer online access to the public. A state-sponsored court automation system is being implemented.
